MINUTES OF THE MEETING HELD ON FRIDAY, MARCH 1ST, 2019, IN CLIVIGER VILLAGE HALL,, CLIVIGER .

1. Code of conduct (Declaration of Interest)

2. Apologies for absence

3. Police report

PSCO Johnstone said there had been 26 incidents since his last report with 12 being non criminal, one malicious, a fatal RTA, public order offence, drink driving case. He said there had been some anti social behaviour problems at Crown Point (Cliviger end). PSCO Johnstone retires on April 5th and will be replaced by PC's Beth Gribble and Chris Jackson.

5. Minutes of the last meeting and matters arising

These were accepted, with the minor amendment at 6 b which should say Coun. Heys asked for an update re High Gates.

5 (a) Land adjacent to Causeway Farm, Long Causeway

BBC's enforcement officer and a planning officer have been dealing with this case. The owner submitted an application for prior notification for an agricultural building on the land, but this could not be accepted due to works which had already been carried out and also the creation of an access road/track within 25 metres of The Long Causeway road. The applicant has been advised to submit a full planning application. The site is being monitored by BBC.

5 (b) Magnolia at Memorial Garden

Coun. Whittle is to buy two replacement magnolias.

5 (c) Honeyholme Lane post box

Royal Mail has submitted plans to re site the post box. MP Julie Cooper has also taken up the case. Coun. Heys suggested it is attached to the bus shelter.

5 (d) HGV sign at the corner/junction of Burnley Road and Park Road

LCC say the work has been completed.

5 (e) High Gates

The BBC enforcement officer says she is not aware of any further works/development at this site, but the site is being monitored.

5 (f) 48 Broad Ing

The BBC enforcement officer says there was a condition on planning requesting the reinstatement of a hedge. A site visit revealed a pallet has been placed to stop access and works appear to be going on in the back garden, so it will be monitored to ensure the hedge is reinstated.

5 (g) Pot holes on Greycliffe Lane

LCC has completed work on this.

6. Allotments

6 (b) Councillors' reports

Coun. Whittle raised a road sign that has been knocked down at Barcroft Green. The clerk to report to LCC and also ask for the council to look at a temporary barrier on Burnley Road at the Co op Buildings, which needs looking at.

She also asked councillors to look at www.davidogilvie.com re the 2018 WW1 bench.

The clerk to also report a wall collapsing on Burnley Road just up from Mount Zion church.

It was agreed that semi grown plants including cow slips and primroses will be planted at the embankment on Burnley Road opposite the hairdressers. Also winter bulbs later in the year.

Coun. Towneley spoke about LCC's consultation on street parking at the operating hours of the household recycling unit.

Coun. Towneley had attended the village hall committee meeting to discuss the council's comments on the constitution. It was agreed to try and encourage village groups to enter the Todmorden Show, especially in light of the fact that there is no flower show this year.

It was agreed to put in a bid from the parish council for funding for a Christmas tree for Walk Mill and plants and bulbs.

It was agreed to fund up to a maximum of £500 towards the police rural 4 x 4. It is understood the whole amount will not probably be needed. Await invoice from police. The vehicle is currently out of action as needs repairing and also awaiting training for officers to use.
